# Who is responsible for the processing of the data?

#### What data do we process, and for which purposes?

We process the data you have submitted to us in connection with your application in order to assess your suitability for the position (or potentially for other vacancies at our company) and within the scope of the application procedure.

#### On what legal basis are you doing this?

The primary legal basis for the processing of your personal data within the scope of this application procedure is Section 16 of the German Federal Data Protection Act (BDSG, last amendment dated 25 May 2018), which permits the processing of the data that is necessary in connection with the decision about potential employment. In the event of the data potentially being required subsequent to the application procedure to ensure compliance with a legal obligation to which the controller is subject to, the data may be processed on the basis of the conditions stated in Article 6 of the GDPR, particularly in the pursuit of our legitimate interests on the lawful basis of Art. 6(1)(f) of the GDPR. In that case, our legitimate interest shall be the establishment or defense of legal claims.

#### How long is the data stored for?

In the event of an unsuccessful application, the applicant data will be deleted after six months, at the latest. If you have consented to the further storage of your personal data, we will include your data in our applicant register, from which it will be deleted after two years, at the latest. Should the application procedure lead to successful employment, the data will be transferred from the applicant system to our personnel data system.
